Chair David Caprio thanked President Warner and the staff of Rhode Island College for hosting the council meeting. Chair Caprio also acknowledged the accolades for both Rhode Island College and the Community College of Rhode Island.

He shared that Rhode Island College senior wrestler Nathan Lackman won the individual national championship at 165 pounds at the 2023 NCAA Division III Wrestling National Championship. He also noted that Rhode Island College Women's Basketball Team captured their third straight Little East Conference Championship and secured an automatic bid into the National Collegiate Athletic Association (NCAA) Division Three National Tournament, where they have advanced to the Final Four. This is the first time they have advanced to the final four in the program's history, and Head Women's Basketball Coach, Jenna Cosgrove was named the Region 2 coach of the year.

Chair Caprio also acknowledged the Community College of Rhode Island, Women's Basketball team which won its second consecutive Region 21 Championship to earn an automatic berth in the NJCAA Division III Women's Basketball Championships. Head Women's Basketball Coach, Doug Haynes was named NJCAA Division III Region 21 coach of the year.

Chair Caprio congratulated the coaches and athletes as well as the school administrators for these achievements and sent wishes for continued success on behalf of the Council.
