# 3. Open Forum

Chair Caprio then announced that the Council will move into Open Forum.

Executive Assistant Jackie Xiong indicated that there were eight requests from the public to participate in Open Forum. Ms. Xiong first introduced Mikaila Mariel Lemonik Arthur, RIC faculty and President of the RIC/AFT. Dr. Arthur addressed the program closures at RIC and urged the Council to deeply reconsider the suspensions.

Next, Leslie A. Schuster, RIC faculty, spoke on Gender and Women's Studies and support for LGBTQ+ inclusion. Dr. Schuster urged for the Council to prioritize student well-being and the broader value of the program over enrollment numbers.

Sylvia Liveda, Director of Portuguese at RIC was next to speak. Director Liveda expressed concern over the proposed closure of the Portuguese program. She also addressed the release of faculty leading to unjust direct consequences of program closures. Director Liveda urged the Council to reconsider the decision, emphasizing the program's importance to the state and its students.

Ms. Xiong called upon Danielle Hurowitz, a first-semester Gender Studies major at RIC. Hurowitz shared that the program was the reason they transferred to the college and further expressed disappointment over its suspension, noting widespread concern among students and alumni. Finally, they urged the Council to expand, not cut, opportunities for students to engage in this vital field of study.

Professor at RIC, Todd Michael Borgerding spoke next. He shared criticism on the process behind the program suspensions at RIC, citing a lack of clear definitions, inconsistent data usage, and limited faculty involvement. He described the review as rushed with flawed metrics and recommendations that could harm student interest and retention. He urged the Council to restart the process thoughtfully, emphasizing RIC's unique role in providing inclusive, high-quality education to all Rhode Islanders.

Ms. Xiong called upon Elisa Miller, professor at RIC, to speak next. Professor Miller criticized the enrollment thresholds used in RIC's program review process, arguing they are disproportionately high for a college of RIC's size and unfairly target smaller departments. She urged the Council and OPC to revise these thresholds to preserve academic diversity and equity.

Luisa M. Pimentel spoke next. The CCRI alumni and president of the Spanish Club urged the Council to stop the suspension of world language majors, especially French and Portuguese. They emphasized the global importance and relevance to Rhode Island's diverse communities.

Ms. Xiong called upon the last participant, Erin Papa, RIC faculty and director of the World Languages Education program. Director Papa opposed the suspension of French and Portuguese concentrations, emphasizing the program's critical role in preparing multilingual education. She noted that minors are insufficient for teacher certification and that RIC is the only public institution in Rhode Island offering a Portuguese major. She urged the Council to invest in and coordinate language education programs rather than eliminate them, highlighting their importance for equity, workforce readiness, and the state's multilingual needs.

Ms. Xiong announced that there were no further requests for open forum.

The second item was the approval of the of selection of the American Beacon Stephens Mid-Cap Gr R6 Fund (SFMRX) to replace the Blackrock Mid-Cap Growth Equity K Fund. Finally, the committee received an update regarding security in executive session.
